## Asbury House COVENANT FOR HOUSE USE

- 1. ROOM ASSIGNMENTS are the sole responsibility of Asbury and are made with the needs of the Student(s) as a community in mind. While changes in room assignment should be rare and Asbury recognizes the inconvenience room changes may cause. Changes in room assignment can be made at the discretion of Asbury with a 10- day written notice from Asbury CDC. Student(s) agree to comply and to cooperate in a manner that brings the least disruption to all Student(s).
- 2. No animals or pets whatsoever shall be brought into or kept on the Asbury House property/premises.
- 3. Access to or use of the roof is prohibited.
- 4. Tampering with or disabling any life/safety system or device is prohibited.
- 5. Flammables, bicycles and motorcycles shall be stored outside in designated areas.
- 6. The possession of firearms or other weapons on the Asbury House property is prohibited.
- 7. The use of burning candles in the Asbury House is prohibited.
- 8. The use or possession of alcohol or illegal substances is prohibited on the Asbury House property/premises.
- 9. Smoking is not allowed on the premises.
- 10. Keep the sidewalk and yard free of toys/bikes/other debris at all times.
- 11. Individuals are responsible for sidewalk and driveway snow removal if there's an accumulation of more than ½ inch.
- 12. Lawn maintenance and leaf removal is the responsibility of individuals residing at the Asbury House.
- 13. The terms listed in this Covenant may be modified from time to time by mutual consent of the Asbury Covenant Committee which includes the residents, representatives of Asbury CDC and local community members. However, the Asbury CDC Board of Directors reserves the right to insist on certain terms and may amend this document without the approval of the Covenant Committee.
